Yet, for the justice-impacted community, this season often highlights a painful void: the separation caused by incarceration.

In the spirit of compassion and restoration, the Prison Ministry is reflecting on—and preparing for—one of our most vital missions: the Mom and Me Camp. This initiative is more than just a getaway; it is a lifeline for families torn apart by the justice system.

Our goal was to provide 40 children with a rare and precious gift: the time to simply "be" with their mothers. Away from the sterile environment of visitation rooms, these children were able to play games, engage in craft projects, and, most importantly, renew their relationships with their mothers in a supportive, joy-filled setting.

We know that when a mother is incarcerated, the impact ripples through the entire family structure. Often, grandmothers, aunts, and sisters step in to fill the gap, taking on the monumental task of raising these young children.

# From the Chair

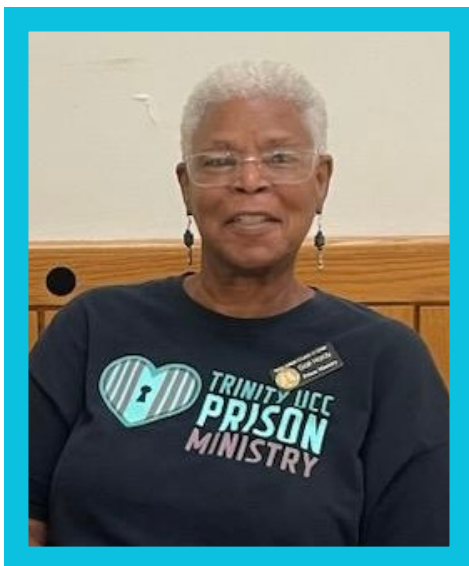
The Tucc Prison Ministry Chair, Gail Hardy shares reflections about 45 years of service to the incarcerated and formerly incarcerated

TWENTY-SIX YEARS—HOW QUICKLY TIME HAS FLOWN. AS I REFLECT ON MY JOURNEY WITH THE PRISON MINISTRY, I REMEMBER THE FRIENDLY SOFTBALL GAMES AT IYC-ST. CHARLES, WHERE WE CHALLENGED THE YOUNG PEOPLE TO SOFTBALL GAMES, AND MY FIRST EYE-OPENING TOUR OF STATEVILLE—WHAT AN INTENSE EXPERIENCE! THANK YOU, DARYLE, FOR BRINGING HUMOR TO SUCH A SOMBER PLACE. I ALSO RECALL MY FIRST VISIT TO THE CC WOMEN'S DIVISION—TEARS STREAMED DOWN MY FACE AS I WITNESSED WOMEN FROM ALL BACKGROUNDS BEING HELD AWAITING TRIAL. THE EARLY DAYS OF MOM & ME COME TO MIND: TRAVELING LONG DISTANCES ON UNCOMFORTABLE YELLOW SCHOOL BUSES TO THE PRISONS, FILLED WITH CHILDREN BUZZING WITH ANTICIPATION, AND MOTHERS WAITING ANXIOUSLY TO SEE THEM ONCE WE ARRIVED. ALL THESE EVENTS AND MORE RESULTED IN LASTING PARTNERSHIPS IN SERVICE TO THE INCARCERATED AND THEIR FAMILIES.

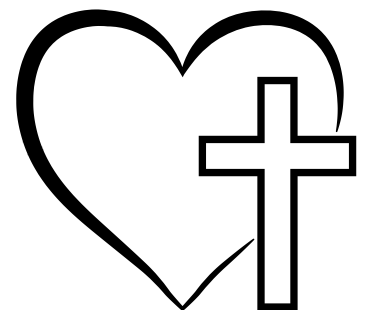

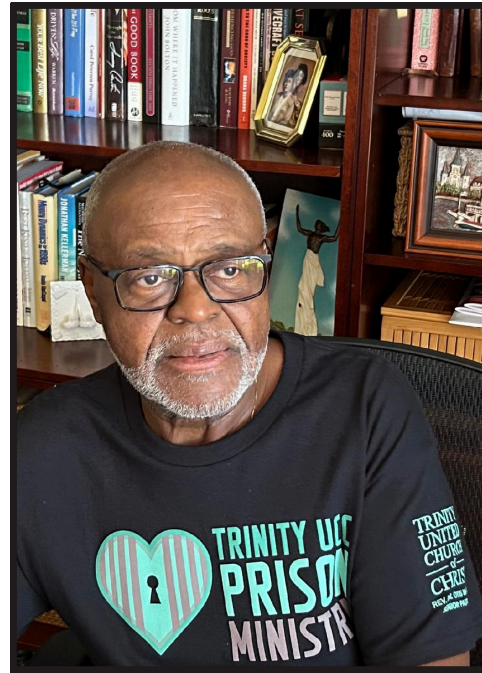
**A Holiday Season of Hope for Mothers of the  
Incarcerated**

The holiday season is often portrayed as a time of joyful reunions, warm gatherings, and family traditions. But for many mothers whose son or daughter is behind bars, this time of year can be one of deep emotional conflict—love that aches, hope that wavers, and heartache that is rarely acknowledged in the glittering glow of holiday celebration.

Some mothers travel for hours, often burdened by financial stress, just to share a few precious hours behind Plexiglas or under watchful eyes. These visits can carry both joy and sorrow; joy in seeing their son or daughter's face, and sorrow in leaving them behind again.

Despite the distance, love does not falter. It endures, adapts, and persists in handwritten letters, in held-back tears, in whispered prayers. Many mothers fight tirelessly advocating for fair treatment, working to stay connected, or preparing for a future when their son or daughter will return home. The strength it takes to maintain hope in the face of uncertainty is a testament to the resilience of a mother's love.

It's okay to grieve the moments that won't be shared—the empty chair at the dinner table, the absence of a hug, or the sound of your offspring's laughter. Allow yourself to feel the sadness, but don't let it drown out your faith. God still sees you. He still loves you, your family and your incarnated son or daughter. And He is still working in ways unseen.



This season, lean into prayer as you stay connected. Every whispered prayer is a thread of love that reaches through prison walls. Write letters filled with encouragement, Scripture, and reminders of who your offspring is beyond their mistakes. These words can become a light in their darkness, a reflection of unconditional love that only a mother can give.

Find a community of mothers who understand. You are not alone in your pain. Sharing stories, tears, and prayers with others can bring comfort and renewed strength. Attend a support group such as our Prison Ministry's support group for families of the incarcerated that meets monthly or create your own circle of hope. Celebrate the love that still binds you, even when distance separates you. Even when your arms can't reach your son or daughter, your prayers can. And that, dear mother, is a powerful gift that no prison wall can contain.



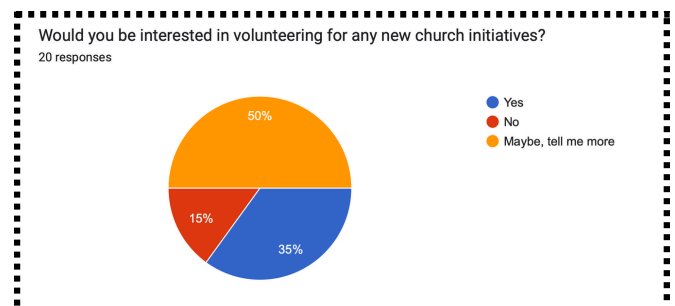
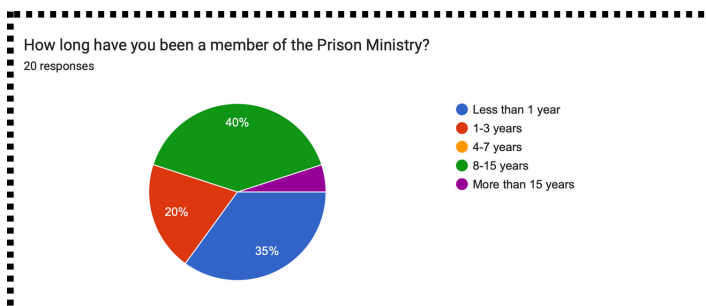
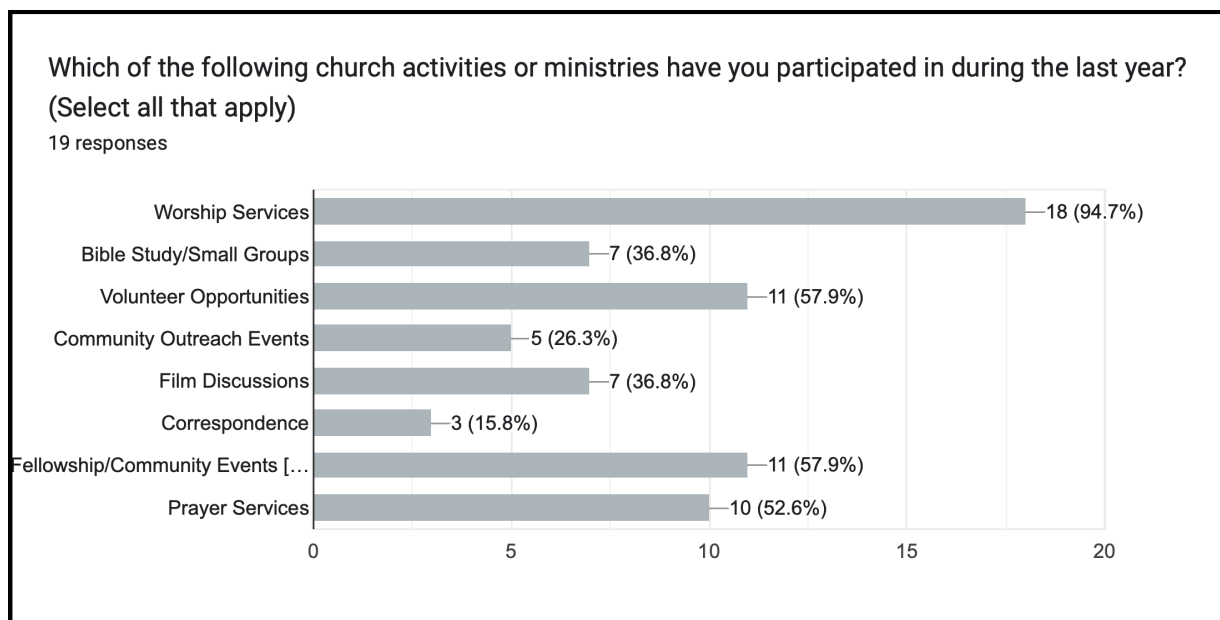
# Prison Ministry 2025 Survey Results

We were also incredibly moved by the specific practical commitments shared in the responses. One member, for instance, voiced a strong desire to increase in-person visits on weekends. This spirit of dedication—using personal gifts and history to fuel our collective mission—is precisely what continues to drive this ministry forward.

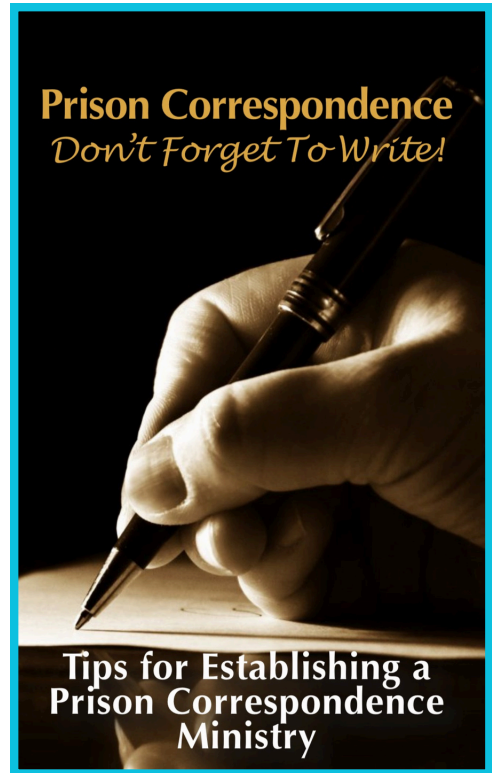
Gail Hardy, Chair

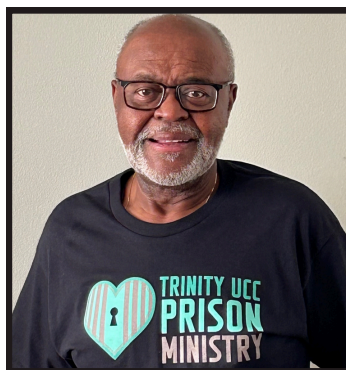


**Our Correspondence Ministry reaches the most vulnerable in the justice-impacted community.**
